

Conditions regarding the 8th Grade Class Trip

- The participant is bound to act according to the arrangements and assignments by the teacher or group leader.
- The students may leave the group without a teacher for the purpose of recreation when accompanied by at least two other students, but only with the permission of a teacher.
- The participant must be healthy and physically able to participate in sports such as skiing and skating (swimming at this time is not being considered). Please note: Your signature also permits the student to participate in activities such as sledding, visit of a horse stable and hiking or ice skating (if possible).
- In case of disobedience or unsocial behavior the participant may be sent home immediately and the parents will pay all expenses. The decision to send home a student is up to the teachers/Hr. Müller.
- In case of sickness the parents will pay all expenses for medical treatment and transportation home (if necessary), if these expenses are not covered by insurance. Any medical expenses incurred by the teacher in Bruck must be paid by the parents immediately after returning into the account listed later.
- Expenses caused by an accident during school related activities will be covered by the school insurance. Reports must be made to school offices especially if symptoms occur after we returned from the trip. Please be aware, that any further treatment upon our return to Berlin must be coordinated through a “Durchgangsarzt”. This is a special licensed orthopedic and surgical doctor.
- The student is responsible for his/her own luggage and equipment. There is no insurance provided by the school.
- The parents discuss with their child before the beginning of the trip **general behavior** and, that **drinking alcohol and smoking are forbidden during the entire trip!**
- The participant must bring a valid passport (or other travel document). Check the expiration date **NOW!** If not privately insured, also bring document from your insurance company.
- Withdrawal from the trip may lead to cancellation fees. Cancellation fees may also apply if the entire trip will be cancelled.
- Students are required to follow hygienic regulations as provided (see form). Disregarding these regulations may lead to the expulsion of the student. Parents should discuss the regulations with their child.

- Advanced skiers (students who can already use a lift) are asked to pay **EURO 25,-** additional lift fees. If skis, ski boots and a ski helmet have to be rented, please add **EURO 65,-** to your payments.
